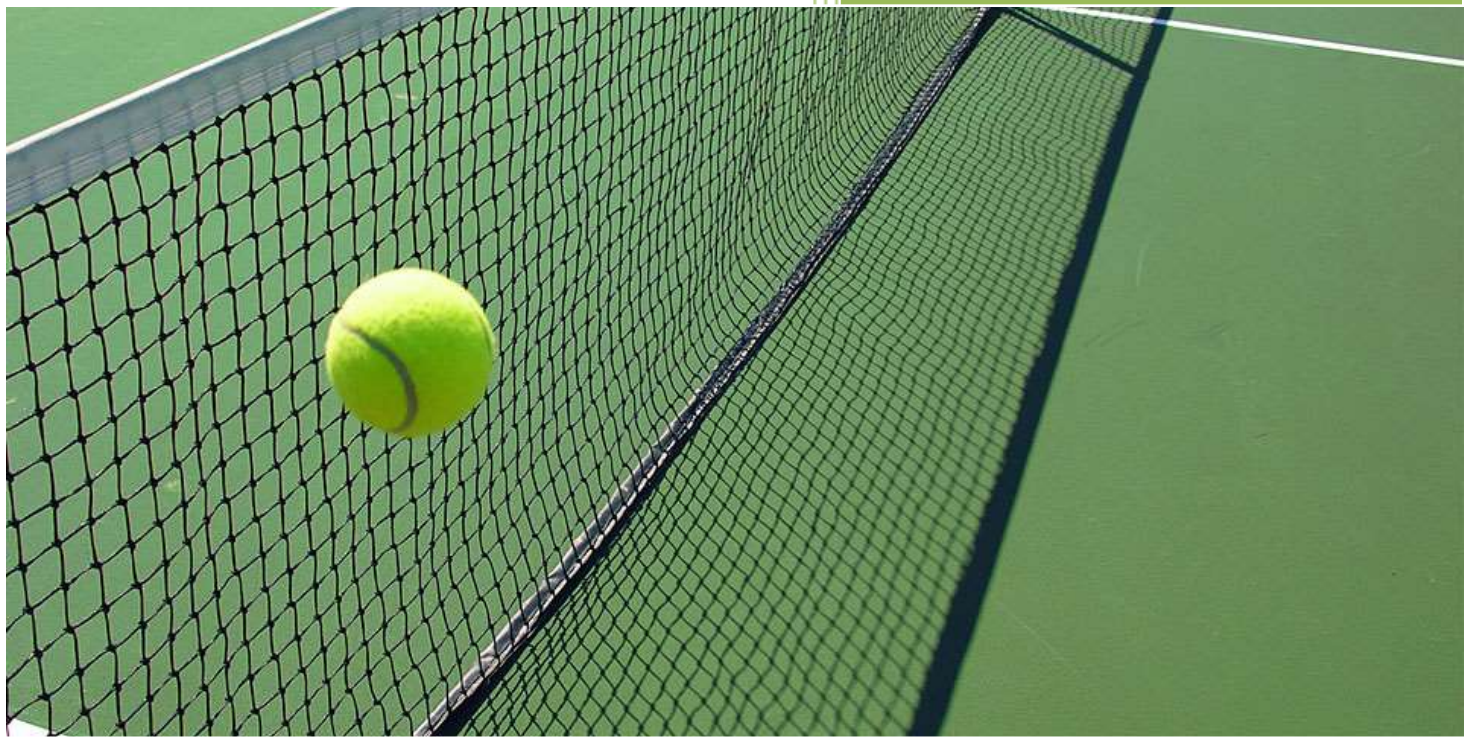

## *Glen Meadows Golf & Country Club*

### TENNIS CLUB RULES

1. Proper tennis attire and court shoes must be worn at all times on the court.
2. Tennis club members and golf members are required to wear membership shoe tags when using the courts.
3. Observe proper court etiquette:
  - a. Avoid crossing behind a court when play is in progress.
  - b. When a ball from another court rolls onto your court: Stop play, call a let, and return it without interfering with the play on that court.
  - c. Make line calls only on your side of the net and be fair - a ball not clearly "out" is "in".
  - d. Wait until opponents are in "ready" position before serving. Do not attempt to return serve if you are not ready - call a let.
  - e. Demonstrate good sportsmanship at all times.
4. All three courts will be reserved for the following activities:
  - a. Mixers on Monday and Friday mornings from 8:30am.
  - b. Monthly round robins, opening day and hospitality day.
  - c. Interclub leagues and tournaments.
5. With the exception of the above scheduled activities the order of play should be as follows:
  - a. If other members are waiting, players are restricted to one short set or a maximum of 30 minutes - including warm-up.
  - b. Players proceed onto courts according to the following guidelines: First complete foursome (doubles) or pair (singles) that are assembled and waiting. If two groups are finished together or are ready at the same time and only one court is available, the one to play should be decided by a toss.
6. Singles follow the above format. A foursome is encouraged if people are waiting.
7. If the play is not scored, practice time is limited to 30 minutes - including warm-up.
8. Please pay in the Pro Shop and place chit in the box on the court entrance gate.
9. Any unresolved issues should be brought to the attention of the tennis club president.
